

Equality within the academy

We welcome our public sector duty under the Equality Act 2010 to publish equality objectives and information. The aim for this is to:

- Eliminate unlawful discrimination, harassment, victimisation and any other conduct prohibited by the Equality Act 2010
- Advance equality of opportunity between people who share a protected characteristic and people who do not share it
- Foster good relations between people who share a protected characteristic and people who do not share it

In all our activities we act in accordance with the equality act and our equality policy which can be found in the policies section on Teams.

As part of this we will:

- Publish information every year about our academy population
- Outline how we have due regard for equality and how we promote community cohesion
- Publish equality objectives to show how we plan to tackle particular inequalities and improve what we do

At the academy we work together to eliminate all forms of discrimination, harassment and victimisation. Progress towards meeting our equalities objectives is reviewed regularly by the senior leadership team and governing body.

Our academy population is predominately 'white-British'. The student population is made up proportionally more boys than girls with 51.5% boys and 48.5% girls. The percentage of students eligible for pupil premium is significantly higher than the national average at 50%, which is the highest it has been in several years. The proportion of students with SEN is marginally higher than the national average at 18.9% with 0.7% who are statemented/EHCP. The Raise Online School Deprivation Indicator shows that the academy's intake comes from areas of significant deprivation. Attendance data for 2016-17 was 94.7%. 1.3% of students are LAC. The Raise Online School Deprivation Indicator shows that the academy's intake comes from areas of significant deprivation. Very few parents have accessed higher education. Attainment on entry is significantly below the national average in all year groups. In year groups 7-11 the proportion of students arriving in the low attainment band is higher than the national average and the proportion of students arriving in the higher attainment band is significantly lower than national average. In Y7, baseline reading tests show 30% of students have a reading age of below 10yrs, of which, 26% are below functional literacy of 9.6yrs.

Our academy improvement plan is compiled each year in discussion with all staff and governors. This makes use of comments from parents and students and aims to address inequalities that are shown through our data and raised through dialogue with all our stakeholders. Our aim is always to ensure that all students reach their full potential and make good progress.

- Track and monitor identified groups and their access and performance and aim to reduce gaps between groups
- Keep a record, where appropriate of the protected characteristics of our students and employees
- The academy has an ICT and E-Safety Policy. Both students and staff have to sign to say they will adhere to the acceptable use policy.
- Our PSHE curriculum aims to eliminate discrimination, harassment and victimisation. The programme delivers differentiated units that support SRE, Careers, Education and Guidance, British Values, Health and wellbeing, Relationships and Economic wellbeing.
- The academy's student leadership structure ensures students contribute towards academy decision making – including Head Boy/Head Girl, Student Leadership Team, Student Council and Student Ambassadors.
- We have a well attended Parent Forum that meets termly
- We have a student Attendance Policy
- Our Admissions Policy clearly sets out our process for admissions.
- Our Grievance Policy sets out clear guidance for staff who wish to make formal complaints.
- We have a Staff Discipline Policy which sets out clear procedures for dealing with any incidents relating to staff.
- The Anti Bullying policy and Child Protection Safeguarding Policy highlight specifically types of abuse and safeguarding roles and responsibilities to protect against them.
